#### Item 2.02 Results of Operations and Financial Condition

Reported GAAP earnings and adjusted non-GAAP earnings for the first quarter of 2023 are expected to include acquired IPR&D and milestones expense of \$150 million on a pre-tax basis, representing an unfavorable impact of \$0.08 to both GAAP diluted earnings per share and adjusted non-GAAP diluted earnings per share. Results for the quarter ended March 31, 2023 have not been finalized and are subject to our financial statement closing procedures. There can be no assurance that our final results will not differ from these preliminary estimates.

While acquired IPR&D and milestones expense may be incurred upon execution of collaborations, licensing agreements, and other asset acquisitions, AbbVie does not forecast acquired IPR&D and milestones expense due to uncertainty of the future occurrence and timing of these transactions. Adjusted diluted earnings per share guidance for 2023 previously announced on February 9, 2023 excluded the impact of acquired IPR&D and milestones expense that may be incurred in 2023. AbbVie's full-year 2023 adjusted diluted earnings per share guidance range, including the impact of first quarter 2023 acquired IPR&D and milestones expense, is \$10.62 - \$11.02. AbbVie's first quarter 2023 adjusted diluted earnings per share guidance range, including the impact of first quarter 2023 acquired IPR&D and milestones expense, is \$2.31 - \$2.41.
